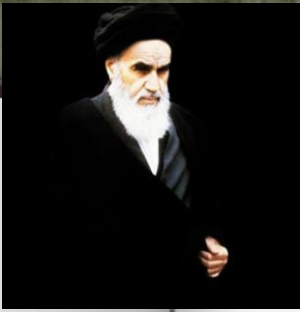

Khums

Khums is a 20 percent obligatory Islamic tax on some items that we own under specific conditions. It is another kind of tax, which is compulsory on six things:

- 1.the booty taken from an enemy in war;
- 2.the pearls and minerals drawn from the sea;
- 3.hidden treasures mineral substances extracted from the land;
- 4.lawfully gained money which has been mixed with unlawful money,
- 5.profits gained from business,
- 6.land transferred to a “dhimmi” (a Christian or a Jew, living within the Muslim nation) from a Muslim.
